1. HAR08-024 - <u>Award of Contract for the Provision and Installation of Refrigerators at Various Housing Commission Sites (Citywide)</u>

Award of a contract to the lowest responsive bidder in the amount of \$840,682 for the provision and installation of refrigerators at various housing sites in the City of San Diego.

Housing Authority approve the following actions:

- 1) Recommend that the Housing Authority approve the award of a contract to M & L Smith, Inc., dba Aztec Appliance, in the amount of \$840,682 for the provision and installation of refrigerators at various Housing Commission sites.
- 2) Authorize the Interim President & Chief Executive Officer to execute the contract (Attachment 1) and expend up to a ten percent contingency (\$84,068) if necessary, for items not anticipated in the original scope of work.
- 3) Request the Housing Authority authorize the Interim President and Chief Executive Officer to amend the FY08 budget to provide for this contract.

2. HAR08-025 - Loan for Golden Age Garden Apartments (Council District 4)
