### **DISCUSSION AGENDA:**

### ITEM 1: HAR20-002 Final Bond Authorization for East Block Family Apartments

Colin Miller, Vice President, Multifamily Housing Finance, Real Estate Division, and Joe Correia, Senior Real Estate Project Manager, Real Estate Division, San Diego Housing Commission, presented the request for approval.

Motion by Council President Gómez to approve the staff-recommended actions. Seconded by Councilmember Sherman and passed by a vote of 9-0.

That the Housing Authority of the City of San Diego (Housing Authority) authorize the issuance of up to \$24,000,000 in tax-exempt Multifamily Housing Revenue Bonds to facilitate Fairmount Family CIC L.P.'s new construction of East Block Family Apartments, which will consist of 77 units that will remain affordable for 55 years and one manager's unit, to be located at 4340 44<sup>th</sup> Street, San Diego, California 92115.

## ITEM 2: HAR20-003 Final Bond Authorization for East Block Senior Apartments

Colin Miller, Vice President, Multifamily Housing Finance, Real Estate Division, and Joe Correia, Senior Real Estate Project Manager, Real Estate Division, San Diego Housing Commission, presented the request for approval.

Motion by Council President Gómez to approve the staff-recommended actions. Seconded by Councilmember Sherman and passed by a vote of 9-0.

That the Housing Authority of the City of San Diego (Housing Authority) authorize the issuance of up to \$22,000,000 in tax-exempt Multifamily Housing Revenue Bonds to facilitate Fairmount Senior Housing CIC L.P.'s new construction of East Block Senior Apartments, which will consist of 115 units that will remain affordable for 55 years and two managers' units, to be located at 4320 44<sup>th</sup> Street, San Diego, California 92115.

# ITEM 3: HAR20-009 Final Bond Authorization for Mission Terrace Apartments

Colin Miller, Vice President, Multifamily Housing Finance, Real Estate Division, and Joe Correia, Senior Real Estate Project Manager, Real Estate Division, San Diego Housing Commission, presented the request for approval.

Motion by Councilmember Sherman to approve the staff-recommended actions. Seconded by Councilmember Moreno and passed by a vote of 9-0.

That the Housing Authority of the City of San Diego (Housing Authority) authorize the issuance of up to \$12,000,000 in Multifamily Housing Revenue Bonds to facilitate Mission Terrace Housing Partners L.P.'s acquisition with rehabilitation of the Mission Terrace Apartments, a 76 unit affordable rental housing development, located at 10210 San Diego Mission Road, San Diego, that will remain affordable for 55 years.
