### REQUESTED ACTION:

Approve a revised resolution authorizing and directing the San Diego Housing Commission (SDHC) to submit an application to the State of California Department of Housing and Community Development (Department) Homekey Program for grant funds in an amount up to \$40,250,000 in accordance with the March 29, 2023, Notice of Funding Availability (NOFA) for the Homekey Program and to enter into, execute and deliver a Standard Agreement in a total amount up to \$40,250,000 and any and all other documents required or deemed necessary or appropriate to secure the Homekey Program funds for the acquisition and rehabilitation of the property at 2087 Hotel Circle South, San Diego, CA 92108, to create permanent affordable rental housing with supportive services for people experiencing homelessness. The revised resolution updates the authorization to execute documents to reflect the position of SDHC's current President and Chief Executive Officer, in accordance with direction from the Department.

### EXECUTIVE SUMMARY OF KEY FACTORS:

- On July 25, 2023, the SDHC Board voted 5-0 to authorize and direct SDHC to apply for Homekey Program funds in an amount up to \$40,250,000 for the acquisition and rehabilitation of the Extended Stay America property at 2087 Hotel Circle South, San Diego, CA 92108, to be known as Presidio Palms, to create permanent affordable rental housing with supportive services for people experiencing homelessness.
- SDHC applied for \$38,500,000. In February 2024, the Department awarded \$35,000,000 to SDHC for Presidio Palms. On June 12, 2025, SDHC and its partners commemorated the grand opening of Presidio Palms.
- At the time of the July 25, 2023, SDHC Board action, Jeff Davis served as SDHC's Interim President and Chief Executive Officer. On December 13, 2023, Lisa C. Jones became SDHC's President and Chief Executive Officer, and Mr. Davis' title changed to Deputy Chief Executive Officer.
- On January 4, 2024, the Department informed SDHC that SDHC would need to submit an updated resolution and signature block that reflected the authorization for Mr. Davis to execute documents for SDHC with his title as Deputy Chief Executive Officer. On February 16, 2024, the SDHC Board approved a revised resolution that updated Mr. Davis' title in accordance with the Department's direction.
- On May 4, 2026, SDHC informed the Department that Mr. Davis had retired from SDHC. The Department then informed SDHC on May 5, 2026, that it required a new resolution replacing Mr. Davis as an authorized signer of documents related to the Homekey funds for Presidio Palms.
- Pursuant to the Department's direction, SDHC staff request the SDHC Board's approval of a revised resolution authorizing SDHC's President and Chief Executive Officer, or designee, to execute documents related to the Homekey funds for Presidio Palms.
- The proposed action has no fiscal impact.

### **REQUESTED ACTION**

Approve a revised resolution authorizing and directing the San Diego Housing Commission (SDHC) to submit an application to the State of California Department of Housing and Community Development (Department) Homekey Program for grant funds in an amount up to \$40,250,000 in accordance with the March 29, 2023, Notice of Funding Availability (NOFA) for the Homekey Program and to enter into, execute and deliver a Standard Agreement in a total amount up to \$40,250,000 and any and all other documents required or deemed necessary or appropriate to secure the Homekey Program funds for the acquisition and rehabilitation of the property at 2087 Hotel Circle South, San Diego, CA 92108, to create permanent affordable rental housing with supportive services for people experiencing homelessness. The revised resolution updates the authorization to execute documents to reflect the position of SDHC's current President and Chief Executive Officer, in accordance with direction from the Department.

### **STAFF RECOMMENDATION**

That the San Diego Housing Commission (SDHC) Board of Commissioners (Board) take the following actions:

- 1) Approve a revised resolution authorizing and directing SDHC to submit an application to the State of California Department of Housing and Community Development (Department) Homekey Program for grant funds in an amount up to \$40,250,000 in accordance with the March 29, 2023, Notice of Funding Availability (NOFA) for the Homekey Program for the acquisition and rehabilitation of the Extended Stay America hotel property at 2087 Hotel Circle South, San Diego, CA 92108, to be known as Presidio Palms, to create permanent affordable rental housing with supportive services for people experiencing homelessness. This revised resolution authorizes SDHC's current President and Chief Executive Officer, Lisa C. Jones, to execute documents, in accordance with direction from the Department.
- 2) If the application is approved, authorize and direct SDHC to enter into, execute, and deliver a Standard Agreement in a total amount up to \$40,250,000 and any and all other documents required or deemed necessary or appropriate to secure Homekey Funds from the Department, and to participate in the Homekey Program, provided that a copy of the documents, signed as to form by General Counsel, is submitted to each Housing Commissioner.

SDHC acknowledges and agrees that it shall be subject to the terms and conditions specified in the Standard Agreement, and that the NOFA and application will be incorporated in the Standard Agreement by reference and made a part thereof. Any and all activities, expenditures, information, and timelines represented in the application are enforceable through the Standard Agreement. Funds are to be used for the allowable expenditures and activities identified in the Standard Agreement.

- 3) Authorize SDHC's President and Chief Executive Officer, or designee, to execute the application and the Homekey Program documents on behalf of SDHC for participation in the Homekey Program.
- 4) Authorize SDHC's President and Chief Executive Officer, or designee, to execute all documents and instruments that are necessary and/or appropriate to implement these approvals, in a form approved by General Counsel, and to take such actions as are necessary and/or appropriate to implement these approvals. provided that a copy of the documents, signed as to form by General Counsel, are submitted to each Housing Commissioner.

### **SUMMARY**

On July 25, 2023, the SDHC Board voted 5-0 to authorize and direct SDHC to apply for Homekey Program funds in an amount up to \$40,250,000 for the acquisition and rehabilitation of the Extended Stay America property at 2087 Hotel Circle South, San Diego, CA 92108, to be known as Presidio Palms, to create permanent affordable rental housing with supportive services for people experiencing homelessness (Attachment 1 – Report No. HCR23-085 and Attachment 2 – Resolution No. HC-1989). SDHC applied for \$38,500,000.

In February 2024, the Department awarded \$35,000,000 to SDHC for Presidio Palms. On June 12, 2025, SDHC and its partners commemorated the grand opening of Presidio Palms.

At the time of the July 25, 2023, SDHC Board action, Jeff Davis served as SDHC's Interim President and Chief Executive Officer. On December 13, 2023, Lisa C. Jones became SDHC's President and Chief Executive Officer, and Mr. Davis' title changed to Deputy Chief Executive Officer. On January 4, 2024, the Department informed SDHC in connection with a separate application for Homekey Program funds that SDHC would need to submit an updated resolution and signature block that reflected the authorization for Mr. Davis to execute documents for SDHC with his title as Deputy Chief Executive Officer. On February 16, 2024, the SDHC Board voted 4-0 to approve a revised resolution authorizing SDHC to apply for Homekey grant funds, with the revised resolution reflecting Mr. Davis' title as Deputy Chief Executive Officer, in accordance with the direction the Department provided to SDHC (Attachment 3 – Report No. HCR24-031 and Attachment 4 – Resolution No. HC-2006).

The Department requires recipients of the awarded Homekey funds to submit annual reports about the projects the funds supported. SDHC submitted the annual report for Presidio Palms in April 2026, and the Department confirmed approval of the report on May 4, 2026, in an email addressed to Mr. Davis. SDHC informed the Department at that time that Mr. Davis had retired from SDHC. The Department then informed SDHC on May 5, 2026, that it required a new resolution replacing Mr. Davis as an authorized signer of documents related to the Homekey funds for Presidio Palms.

Pursuant to the Department's direction, SDHC staff request the SDHC Board's approval of a revised

resolution (Attachment 5) authorizing SDHC's President and Chief Executive Officer, or designee, to execute documents related to the Homekey funds for Presidio Palms.

### **AFFORDABLE HOUSING IMPACT**

The SDHC Board previously authorized SDHC to apply for up to \$40,250,000. SDHC's application, if selected for funding, would have increased funds available for use within the City of San Diego by \$40,250,000 to support the development of affordable rental housing for individuals experiencing homelessness. The Department awarded \$35,000,000 to SDHC for this project. SDHC committed 161 Project-Based Housing Vouchers (PBVs) to this project. Under the PBV program, the tenant's rent portion is determined by using the applicable minimum rent or a calculated amount based on their income level, whichever is higher, with the remainder being federally subsidized up to a gross rent level approved by SDHC.

### **FISCAL CONSIDERATIONS**

SDHC's application for Homekey Program funds, as authorized by the SDHC Board, and the Department's award of Homekey Program funds to SDHC occurred in Fiscal Year 2024. On June 25, 2024, the Housing Authority of the City of San Diego authorized SDHC to accept \$35,000,000 in State of California Homekey Program funds, \$17,806,432 in City of San Diego HOME Investment Partnerships American Rescue Plan Act (HOME-ARP) funds, \$17,806,432 in County of San Diego American Rescue Plan Act (ARPA) funds, and \$1,100,000 in San Diego Regional Task Force on Homelessness funds; to expend \$71,712,864 for the acquisition and rehabilitation of real property known as Extended Stay America at 2087 Hotel Circle South, San Diego, California (property); and to acquire and rehabilitate the property, to be known as Presidio Palms (Resolution No. HA-2019).

The potential award of Homekey Program funds was included in SDHC's approved Fiscal Year 2025 budget. As such, this action has no fiscal impact.

### **SDHC STRATEGIC PLAN**

This item related to Strategic Priority Areas No. 1 and No.4 in SDHC's Strategic Plan for Fiscal Year (FY) 2022-2024. No.1: Increasing and Preserving Housing Solutions. No.4: Advancing Homelessness Solutions – Supporting the City of San Diego Community Action Plan on Homelessness. The proposed revised resolution relates to those Strategic Priority Areas as well as Strategic Priority Areas No. 3 and No. 5 in SDHC's Strategic Plan for FY 2026-2030. No. 3: Create and Preserve Housing. No. 5: Address and Prevent Homelessness.

## **ENVIRONMENTAL REVIEW**

### California Environmental Quality Act

The application for HCD funding is not a project as defined by the California Environmental Quality Act Section 21065 and State CEQA Guidelines Section 15378(b)(5), as it is an administrative activity of government that will not result in direct or indirect physical changes in the environment. Existing environmental review for this project applies to the rehabilitation of the property and includes the following: "On April 27, 2023 the City of San Diego conducted an environmental review and determined the project is exempt from CEQA pursuant to CEQA Guidelines Section 15301 (Existing Facilities) and 15304 (Minor Alterations to Land). This activity is exempt pursuant to CEQA Guidelines Section 15301 (Existing Facilities), as there are no changes planned to building and unit footprints, or property use. The activity is also exempt pursuant to 15304 (Minor Alterations to Land), as the renovations will be limited to immediate needs such as those identified for fire and life safety, accessibility and path of travel, and remediation for hazardous materials and pests. None of the exceptions to the exemptions as outlined in CEQA Guidelines Section 15300.2 would apply.

### National Environmental Policy Act

Federal funds constitute a portion of the project's funding. A determination that the project is categorically excluded subject to Section 58.5 of the National Environmental Policy Act was approved by the City of San Diego on May 4, 2023. Further review under the National Environmental Policy Act is not required as this application is for state funding only.

### **SUMMARY**

The Department has issued a NOFA, dated March 29, 2023, for the Homekey Program, which continues a statewide effort to sustain and rapidly expand housing for persons experiencing homelessness or at risk of homelessness, and who are, thereby, disproportionately impacted by and at increased risk for medical diseases or conditions due to the COVID-19 pandemic or other communicable diseases. The Department has issued the NOFA for Homekey Program grant funds pursuant to Assembly Bill 140 (2021-2022 Regular Session), which provided the statutory basis for Round 3 of the Homekey Program by adding section 50675.1.3 to the California Health and Safety Code.

The Housing Commission is requesting the Housing Commission Board’s approval to submit an application to the Department’s Homekey Program for grant funds. Acceptance of the grant funds, if awarded, will be presented to the Housing Authority of the City of San Diego together with staff-recommended actions to approve the proposed project that the Homekey Program funds would support.

Through the Homekey Program, the Department is making \$736 million in grant funding available to local public entities, including cities, counties, or other local public entities, including housing authorities or federally recognized tribal governments within California. Awarded funds may be used for acquisition or rehabilitation of hotels, apartments, or homes, including manufactured housing, to be converted into permanent or interim housing; conversion of nonresidential properties into residential units; new construction; master leasing of properties for non-congregate housing; purchase of affordability covenants and restrictions for units; relocation costs for individuals being displaced as a result of the Homekey Program project; and capitalized operating subsidies for units purchased, converted, constructed, or altered.

The Housing Commission’s proposed application, if funds are awarded, would support the acquisition and development of the Extended Stay America at 2087 Hotel Circle South, San Diego, CA 92108, in Council District 3, to be known as Presidio Palms, which currently consists of 165 units. The proposed development would consist of 161 affordable rental housing units dedicated to individuals experiencing homelessness and two managers’ unit. After evaluation of the supportive services needs at this property, it was determined that two hotel units should be converted into additional space for service provider activities. The Housing Commission has committed federal Project-Based Housing Vouchers to help pay rent for residents of 161 affordable units that this project would create for people experiencing homelessness. Residents would receive supportive services to support housing stabilization, enhance quality of life and make connections to community resources, including but not limited to, primary health needs, mental and behavioral health needs and other community-based programs to best meet a resident’s individual needs.

The population intended for this site would consist of people experiencing chronic homelessness; people experiencing literal homelessness; and Transition-Age Youth in need of permanent affordable rental housing with supportive services. Residents would be identified through referrals from the Coordinated Entry System.

The proposed project aligns with the goals of the Community Action Plan on Homelessness for the City of San Diego to increase access to permanent housing solutions for people experiencing homelessness and increase access to services for people with behavioral health needs.

Homekey Program funds consist of \$435 million derived from the federal Coronavirus State Fiscal Recovery Fund (CSFRF), established by the federal American Rescue Plan Act of 2021 (ARPA) (Public Law 117- 2), and \$301 million from the state’s General Fund.

The Department is authorized to administer the Homekey Program pursuant to the Multifamily Housing Program (Chapter 6.7, commencing with Section 50675, of Part 2 of Division 31 of the Health and Safety Code). Homekey Program funding allocations are subject to the terms and conditions of the NOFA, ARPA guidance, the Application, the Department-approved STD 213, Standard Agreement (Standard Agreement), and all other legal requirements of the Homekey Program.

**AFFORDABLE HOUSING IMPACT**

This application, if selected for funding, would increase funds available for use within the City of San Diego by \$40,250,000 to support the development of affordable rental housing for individuals experiencing homelessness.

**FISCAL CONSIDERATIONS**

If Homekey Program funds are awarded to the Housing Commission, the award is anticipated to occur early in Fiscal Year 2024. The potential award of Homekey Program funds was not included in the Housing Commission’s proposed Fiscal Year 2024 budget, which the Housing Authority of the City of San Diego approved on June 12, 2023. If the Housing Commission is authorized to apply for funds and if the funds are awarded to the Housing Commission, it will increase the Fiscal Year 2024 funding sources and uses available by up to \$40,250,000 to support the proposed project.

- On July 25, 2023, the San Diego Housing Commission (Housing Commission) Board of Commissioners (Board) authorized and directed the Housing Commission to apply for Homekey Program funds in an amount up to \$40,250,000 for the acquisition and rehabilitation of the Extended Stay America property at 2087 Hotel Circle South, San Diego, CA 92108, to be known as Presidio Palms, to create permanent affordable rental housing with supportive services for people experiencing homelessness.
- The Housing Commission applied for \$38,500,000. The Housing Commission is awaiting notification from the Department about whether Homekey Program funds will be awarded to the Housing Commission for this application.
- At the time of the July 25, 2023, Housing Commission Board action, Jeff Davis served as the Housing Commission's Interim President and Chief Executive Officer and was authorized to execute documents submitted to the Department.
- On December 13, 2023, Lisa Jones became the Housing Commission's President and Chief Executive Officer, and Mr. Davis' title changed to Deputy Chief Executive Officer.
- On January 4, 2024, the Department informed Housing Commission staff in connection with a separate application for Homekey Program funds that the Housing Commission would need to submit an updated resolution and signature block that reflected the authorization for Mr. Davis to execute documents for the Housing Commission with his current title as Deputy Chief Executive Officer.
- This project would support the development of 161 affordable rental housing units with supportive services for individuals experiencing homelessness. ### **SUMMARY**

On July 25, 2023, the Housing Commission Board voted 5-0 to authorize and direct the Housing Commission to apply for Homekey Program funds in an amount up to \$40,250,000 for the acquisition and rehabilitation of the Extended Stay America property at 2087 Hotel Circle South, San Diego, CA 92108, to be known as Presidio Palms, to create permanent affordable rental housing with supportive services for people experiencing homelessness (Report No. HCR23-085; Resolution No. HC-1989). The Housing Commission applied for \$38,500,000. The Housing Commission is awaiting notification from the Department about whether Homekey Program funds will be awarded to the Housing Commission for this application. At the time of the July 25, 2023, Housing Commission Board action, Jeff Davis served as the Housing Commission’s Interim President and Chief Executive Officer. On December 13, 2023, Lisa Jones became the Housing Commission’s President and Chief Executive Officer, and Mr. Davis’ title changed to Deputy Chief Executive Officer. On January 4, 2024, the Department informed the Housing Commission in connection with a separate application for Homekey Program funds that the Housing Commission would need to submit an updated resolution and signature block that reflected the authorization for Mr. Davis to execute documents for the Housing Commission with his current title as Deputy Chief Executive Officer.

The Department issued a NOFA, dated March 29, 2023, for the Homekey Program, which continues a statewide effort to sustain and rapidly expand housing for persons experiencing homelessness or at risk of homelessness, and who are, thereby, disproportionately impacted by and at increased risk for medical diseases or conditions due to the COVID-19 pandemic or other communicable diseases. The Department issued the NOFA for Homekey Program grant funds pursuant to Assembly Bill 140 (2021-

2022 Regular Session), which provided the statutory basis for Round 3 of the Homekey Program by adding section 50675.1.3 to the California Health and Safety Code.

The Housing Commission requested the Housing Commission Board's approval to submit an application to the Department's Homekey Program for grant funds. Acceptance of the grant funds, if awarded, will be presented to the Housing Commission Board together with staff-recommended actions to approve the proposed project that the Homekey Program funds would support.

Through the Homekey Program, the Department is making \$736 million in grant funding available to local public entities, including cities, counties, or other local public entities, including housing authorities or federally recognized tribal governments within California. Awarded funds may be used for acquisition or rehabilitation of hotels, apartments, or homes, including manufactured housing, to be converted into permanent or interim housing; conversion of nonresidential properties into residential units; new construction; master leasing of properties for non-congregate housing; purchase of affordability covenants and restrictions for units; relocation costs for individuals being displaced as a result of the Homekey Program project; and capitalized operating subsidies for units purchased, converted, constructed, or altered.

The Housing Commission's application, if funds are awarded, would support the acquisition and development of the Extended Stay America at 2087 Hotel Circle South, San Diego, CA 92108, in Council District 3, to be known as Presidio Palms, which currently consists of 165 units. The proposed development would consist of 161 affordable rental housing units dedicated to individuals experiencing homelessness and two managers' unit. After evaluation of the supportive services needs at this property, it was determined that two hotel units should be converted into additional space for service provider activities. The Housing Commission has committed federal Project-Based Housing Vouchers to help pay rent for residents of 161 affordable units that this project would create for people experiencing homelessness. Residents would receive supportive services to support housing stabilization, enhance quality of life and make connections to community resources, including but not limited to, primary health needs, mental and behavioral health needs and other community-based programs to best meet a resident's individual needs.

The population intended for this site would consist of people experiencing chronic homelessness; people experiencing literal homelessness; and Transition-Age Youth in need of permanent affordable rental housing with supportive services. Residents would be identified through referrals from the Coordinated Entry System.

The proposed project aligns with the goals of the Community Action Plan on Homelessness for the City of San Diego to increase access to permanent housing solutions for people experiencing homelessness and increase access to services for people with behavioral health needs.

Homekey Program funds consist of \$435 million derived from the federal Coronavirus State Fiscal Recovery Fund (CSFRF), established by the federal American Rescue Plan Act of 2021 (ARPA) (Public Law 117- 2), and \$301 million from the state's General Fund.

Homekey Program funding allocations are subject to the terms and conditions of the NOFA, ARPA guidance, the Application, the Department-approved STD 213, Standard Agreement (Standard Agreement), and all other legal requirements of the Homekey Program.

**AFFORDABLE HOUSING IMPACT**

This application, if selected for funding, would increase funds available for use within the City of San Diego by \$40,250,000 to support the development of affordable rental housing for individuals experiencing homelessness. The Housing Commission has committed 161 Project-Based Housing Vouchers (PBVs) to this project. Under the PBV program, the tenant’s rent portion is determined by using the applicable minimum rent or a calculated amount based on their income level, whichever is higher, with the remainder being federally subsidized up to a gross rent level approved by the Housing Commission.

**FISCAL CONSIDERATIONS**

If Homekey Program funds are awarded to the Housing Commission, the award is anticipated to occur in Fiscal Year 2024. The potential award of Homekey Program funds was not included in the Housing Commission’s proposed Fiscal Year 2024 budget, which the Housing Authority of the City of San Diego approved on June 12, 2023. If the funds are awarded to the Housing Commission, it will increase the Fiscal Year 2024 funding sources and uses available by up to \$40,250,000 to support the proposed project.

This activity is exempt pursuant to CEQA Guidelines Section 15301 (Existing Facilities), as there are no changes planned to building and unit footprints, or property use. The activity is also exempt pursuant to 15304 (Minor Alterations to Land), as the renovations will be limited to immediate needs such as those identified for fire and life safety, accessibility and path of travel, and remediation for hazardous materials and pests. None of the exceptions to the exemptions as outlined in CEQA Guidelines Section 15300.2 would apply. The City of San Diego approved a National Environmental Policy Act determination that this project is Categorical Excluded Subject to Section 58.5 on May 4, 2023 and approved a Categorical Excluded Not Subject to Section 58.5 determination for supplemental funding on July 27, 2023.
