






SDHC - City of San Diego FY 2024 AHF Annual Plan Inclusionary Housing Fund

- Transitional housing and rapid rehousing







SDHC - City of San Diego FY 2024 AHF Annual Plan Staff Recommendations

That the SDHC Board of Commissioners recommend that the San Diego City Council take the following actions:

- 1) Approve the Proposed Fiscal Year 2024 Affordable Housing Fund (AHF) Annual Plan (Annual Plan) Program Activity Allocation of \$50,693,499 in anticipated funds (also included in the FY 2024 Housing Commission Proposed Budget) and the proposed Model Programs.
- 2) Authorize SDHC's President & Chief Executive Officer, or designee, to reallocate funds among the proposed Model Programs included in the FY 2024 AHF Annual Plan in response to market demands and opportunities.
