San Diego City Council approves funding for The 1,000 Homeless Veterans Initiative
On March 1, 2016, the San Diego City Council unanimously approved funding for The 1,000
Homeless Veterans Initiative of HOUSING FIRST-SAN DIEGO, SDHC's three-year

Homelessness Action Plan (2014-2017). This initiative will invest close to \$12.5 million in Federal, City and SDHC resources to provide housing opportunities for 1,000 homeless Veterans over the next year. This includes \$7 million that the City Council authorized, and which the SDHC Board of Commissioners recommended, including: \$4 million in City funds resulting from the ground lease of San Diego Square; and up to \$3 million from SDHC's pending sale of Hotel Metro.

The City Council's action also funds the "Housing Our Heroes" landlord outreach incentive campaign, which is one of four program components of The 1,000 Homeless Veterans Initiative. CEO Testimony before the California Senate Committee on Transportation & Housing

On Wednesday, March 9, President & CEO Gentry testified to the California Senate Committee on Transportation and Housing about an SDHC study on reducing housing construction costs. The report, titled <u>Addressing the Housing Affordability Crisis: An Action Plan for San Diego</u>, includes 11 recommended actions at the Local, State, or Federal level, such as shortening the permit approval process, deferring development fees, and unlocking underutilized land.

The report was also highlighted in a blog that was posted on the website of the California Economic Summit.

101 HCR16-024 Final Bond Authorization for Fairbanks Terrace

That the San Diego Housing Commission (Housing Commission) recommend the Housing Authority of the City of San Diego (Housing Authority) authorize the issuance of up to \$15,300,000 in tax-exempt multifamily housing revenue bonds/note to fund the construction of Fairbanks Terrace, an 83-unit affordable housing development for seniors age 62 and older, to be located in Black Mountain Ranch at the intersection of Paseo del Sur and Del Sur Ridge Road.

102 <u>HCR16-025</u> <u>Final Bond Authorization for Mesa Verde (formerly known as Mission Gorge) Apartments</u>

That the San Diego Housing Commission (Housing Commission) recommend the Housing Authority of the City of San Diego (Housing Authority) authorize the issuance of up to



\$22,400,000 in tax-exempt multifamily housing revenue bonds/note to fund the construction of Mesa Verde (formerly known as Mission Gorge) Apartments, a 90-unit affordable housing development for families, to be located in the Navajo community at 7785 Mission Gorge Road.

103 HCR16-026 Fiscal Year 2017 Moving to Work Annual Plan Approval

That the San Diego Housing Commission (Housing Commission) take the following actions:

- 1) Approve the Fiscal Year (FY) 2017 Moving to Work (MTW) Annual Plan; and
