Fairbanks Commons project by a limited partnership comprised of Chelsea Investment Corporation, Pacific Southwest Community Development Corporation and the tax credit investor;

- b. Approve an application (and subsequent applications for up to one year, if necessary) to the California Debt Limit Allocation Committee ("CDLAC") for an allocation of authority to issue tax-exempt "private activity bonds" in an amount up to \$46.8 million for Fairbanks Commons;
- c. Approve the financing team of Orrick Herrington & Sutcliffe LLP as bond counsel and The PFM Group as financial advisor to begin work on the project; and,
- 2) That the City Council hold a Tax Equity and Fiscal Responsibility Act ("TEFRA") public hearing, and adopt a resolution approving the issuance of tax-exempt bonds in an amount up to \$46.8 million by the Housing Authority for Fairbanks Commons.
- Authorize the President & Chief Executive Officer ("President & CEO") of the Housing Commission, or designee, to execute all necessary documents, in a form approved by General Counsel and/or Bond Counsel, and to perform such acts as are necessary to implement these approvals.

4. HAR12-034 – <u>Ninth and Broadway - Preliminary Multifamily Housing Revenue Bond</u> <u>Items</u>

Seek Housing Authority of the City of San Diego approval, as described in this report, for the following:

- 1) Approve initial steps to issue Housing Authority multifamily mortgage revenue bonds for this project, including:
 - a. Issue a bond inducement resolution (Declaration of Official Intent) for up to \$24,000,000 in multifamily housing revenue bonds for new construction of Ninth and Broadway by a to-be-formed limited partnership.

 - c. Approve a bond financing team of Quint & Thimmig as bond counsel and CSG Advisors as bond financial advisor.
 - d. Request that the City Council hold a Tax Equity and Fiscal Responsibility Act ("TEFRA") public hearing, and adopt a resolution approving the Housing Authority's issuance of tax-exempt bonds in an amount of up to \$24,000,000.
- 2) Authorize the President & Chief Executive Officer of the Housing Commission ("President & CEO"), or his designee to execute any and all documents and instruments, in a form approved by General Counsel and bond counsel, and to perform such acts as are necessary to implement these approvals, and to adjust terms/conditions as necessary for consistency with requirements of third-party funding sources or to accommodate market changes that may occur after approval of this report but before close of escrow.



5. HAR12-033 – Fiscal Year 2013 Section 8 Administrative Plan

That the Housing Authority of the City of San Diego ("Housing Authority"):

- Approve the FY2013 Section 8 Administrative Plan ("Administrative Plan") that clarifies Housing Commission policy including the Moving to Work ("MTW") initiatives previously approved by the Housing Commission Board on March 16, 2012;
- 2) Ratify the Housing Commission's FY2013 Administrative Plan, as referenced herein, as previously amended, as authorized by San Diego Municipal Code 98.0301(d)(3) and (d)(8);
- 3) Ratify authority to the Housing Commission Board to make amendments to, and adopt Administrative Plans and MTW initiatives as authorized by San Diego Municipal Code Section 98.0301(d)(3) and 98.0301(7); and
- 4) Authorize the President & Chief Executive Officer ("President & CEO") of the Housing Commission, or designee, to execute any and all documents that are necessary and/or appropriate to implement these approvals, subject to approval of the General Counsel, and to take such actions as are necessary and appropriate to implement these approvals.
