A RESOLUTION OF THE HOUSING AUTHORITY OF THE CITY OF SAN DIEGO APPROVING A REVISION TO THE FISCAL YEAR 2012 SAN DIEGO HOUSING COMMISSION BUDGET AND AUTHORIZING THE SAN DIEGO HOUSING COMMISSION TO ENTER INTO A CONTRACT WITH ALPHA PROJECT FOR THE HOMELESS TO OPERATE THE NEIL GOOD DAY CENTER IN FISCAL YEAR 2012.

WHEREAS, the Neil Good Day Center (Center), located in downtown San Diego, offers a day center for homeless individuals; and

WHEREAS, the Center offers homeless individuals various services including case management, showers, laundry, and mail and message service; and

WHEREAS, the San Diego Housing Commission administers the City's homeless shelters and services program pursuant to a Memorandum of Understanding; and

WHEREAS, in the past, the City Council voted to fund the Center with Community

Development Block Grant (CDBG) funds; and

WHEREAS, the City Council did not vote to fund the Center with CDBG funds for Fiscal Year 2012; and

WHEREAS, in order for the San Diego Housing Commission to finance the Center for Fiscal Year 2012, funds in the amount of \$500,000 must be transferred from the San Diego Housing Commission's unobligated reserves fund to the San Diego Housing Commission's Special Housing Initiatives loans and grants fund; NOW, THEREFORE,

BE IT RESOLVED, by the Housing Authority of the City of San Diego, as follows:

- 1. That it approves a revision to the San Diego Housing Commission's Fiscal Year 2012 budget by transferring \$500,000 from the San Diego Housing Commission's unobligated reserves fund to the San Diego Housing Commission's Special Housing Initiatives loans and grants fund.
- 2. That it authorizes the San Diego Housing Commission to enter into a contract, attached to Housing Authority Report No. HAR 11-032, with Alpha Project for the Homeless for the operation of the Neil Good Day Center in Fiscal Year 2012.
- 3. That it authorizes the President and Chief Executive Officer of the San Diego Housing Commission, or designee, to execute the contract, a copy of which is on file with the Deputy Secretary as Document No. ______.
