Ratification of FY2013 CDBG Applications and Authorization of Future

# **REQUESTED ACTION:**

Ratify submission of applications to the City of San Diego for Fiscal Year 2013 (FY13) Community Development Block Grant (CDBG) funds and authorize the President and Chief Executive Officer of the Housing Commission to execute agreements with the City of San Diego for any and all amounts ultimately awarded without further action by the Housing Authority and/or Board of Commissioners of the Housing Commission. It is also requested that in future years only the approval from the Housing Commission Board will be required to submit the applications, if any, since the ultimate award will be approved by the City Council itself.

### STAFF RECOMMENDATION:

Request the Housing Authority:

- Ratify submission of applications to the City of San Diego for FY13 CDBG funds (Attachment)
  and authorize the President and Chief Executive Officer of the Housing Commission to execute
  agreements with the City for any and all amounts ultimately awarded without further action by
  the Housing Authority and/or Board of Commissioners of the Housing Commission.
- 2. In addition, in subsequent years, authorize the Housing Commission to submit applications to the City for CDBG funding without the advance approval of the Housing Authority and authorize the President and CEO to execute all documents necessary to accept such grants as approved and awarded by the City of San Diego.

# **SUMMARY:**

On December 12, 2011, the Housing Commission submitted the following five applications:

The proposed action will allow for the acceptance of any and all awards made by the City without further action by the Housing Authority. It will also allow submission for CDBG awards in subsequent

years if approved by the Housing Commission Board and will allow the President and CEO to execute documents necessary to accept those awards granted by the City without further approvals by either the Housing Commission Board and/or the Housing Authority. This will streamline the application and award process. It will also insure that each application is properly vetted before the City Council since each award will be made by the City Council itself.

# FISCAL CONSIDERATIONS:

The amount the Housing Commission may receive could be substantially different from the amount requested. Therefore, it is not possible to identify fiscal impact at this point in the application process.

# PREVIOUS COUNCIL and/or COMMITTEE ACTION:

On December 9, 2011, the Housing Commission Board unanimously approved submission of the FY13 CDBG applications. The applications were submitted to the City's CDBG office on December 12, 2011.

### **ENVIRONMENTAL REVIEW:**

An application for funding is not a "project" within the meaning of the California Environmental Quality Act of 1970 and no environmental review is required. This activity is exempt from review under the National Environmental Policy Act pursuant to 24 CFR 58.34(a)(3).
