A RESOLUTION OF THE HOUSING AUTHORITY OF THE CITY OF SAN DIEGO ("HOUSING AUTHORITY") RATIFYING SUBMISSION BY THE SAN DIEGO HOUSING COMMISSION ("COMMISSION") OF COMMUNITY DEVELOPMENT BLOCK GRANT ("CDBG") APPLICATIONS IN FY2013 AND IN FUTURE YEARS; AND AUTHORIZING THE PRESIDENT AND CHIEF EXECUTIVE OFFICER OF THE SAN DIEGO HOUSING COMMISSION TO ACCEPT ANY CDBG GRANTS AWARDED IN FY2013 AND IN FUTURE YEARS AND TO EXECUTE AGREEMENTS WITH THE CITY OF SAN DIEGO FOR THOSE FUNDS WITHOUT FURTHER ACTION OF THE COMMISSION OR THE HOUSING AUTHORITY.

WHEREAS, the Board of Commissioners of the San Diego Housing Commission (Housing Commission) on December 9, 2011, authorized submission of applications to the City of San Diego for Fiscal Year (FY) 2013 Community Development Block Grant (CDBG) funds as outlined in Housing Commission Report No. HCR11-141, dated December 1, 2011; and

WHEREAS, to streamline the application process, the Housing Commission is requesting that the Housing Authority of the City of San Diego (Housing Authority) ratify the submission of CDBG applications in FY2013 and authorize the submission of applications in future years, without prior Housing Authority approval; and

WHEREAS, to streamline the award process, the Housing Commission is requesting that the Housing Authority authorize the President and Chief Executive Officer (CEO) of the Housing Commission to accept any CDBG funds awarded in FY2013 and in future years, and to

execute agreements with the City of San Diego for those funds, without further action of the

Housing Commission or the Housing Authority; NOW THEREFORE,

BE IT RESOLVED, by the Housing Authority of the City of San Diego (Housing

Authority), as follows:

1. That the President and Chief Executive Officer (CEO) of the San Diego Housing

Commission, or designee, is authorized to submit applications for CDBG funds in FY2013 as

outlined in Housing Authority Report No. HAR 12-008, dated January 19, 2012; and

2. That the CEO, or designee, of the San Diego Housing Commission is authorized

to submit applications for CDBG funds in FY2014 and in future years, without prior approval of

the Housing Authority; and

3. That the CEO is authorized to accept any CDBG grants awarded in FY2013 and

in future years, and to execute agreements with the City of San Diego for those funds, without

further action of the Housing Commission or the Housing Authority.
