SUMMARY:

The San Diego Housing Commission (“Housing Commission”) has been requested to submit a grants activity report to the Housing Commission Board and Housing Authority of the City of San Diego (“Housing Authority”), on a semi-annual basis.

The Semi-Annual Grants Report shown in Attachment 1 covers the period of January 2012 – June 2012. There were five applications for grant funding made during this period, representing \$2,046,324 million in requested funding. Of these applications, three were new sources, for a total of \$1,963,986 in potential new revenue; two applications were for renewal funding, totaling \$82,338.

During this same period, the Housing Commission received six grant awards, totaling \$4,078,636 million dollars. Of the awarded grants, three were new and represent new funding in the amount of \$828,078 and three awards were for renewal funding, totaling \$3,250,558 million. Refer to Attachment 1 for a more detailed description of the grant activity.

BACKGROUND:

In 2007, the Housing Authority adopted Resolution Number HA1360, Attachment 2, to simplify the application process for resident initiatives grant applications. The resolution authorized the Housing Commission Board to approve the submission of grant applications for resident initiative programs and to amend the Housing Commission budget to include funds that were awarded. The resolution also requested that a semi-annual grant activity report be provided to the Housing Authority.

Since that time the Housing Commission has prepared and submitted to the Housing Authority a semi-annual grants report for **all** grant activity, not limited to the grant applications for resident initiatives programs. The report includes grant applications, grant awards, and grant applications not awarded.


The attached Housing Commission Grants Report, for the period of January 2012 - June 2012, is in fulfillment of that requirement.



A RESOLUTION AUTHORIZING THE CHIEF EXECUTIVE OFFICER TO:
1) SUBMIT CERTAIN APPLICATIONS FOR FUNDING TO THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT; 2) IF FUNDS ARE AWARDED, AMEND THE FY08 HOUSING COMMISSION BUDGET TO REFLECT THE ADDITIONAL FUNDS; AND 3) AUTHORIZE THE HOUSING COMMISSION BOARD TO APPROVE FUTURE SUBMISSIONS OF GRANT APPLICATIONS FOR RESIDENT INITIATIVES PROGRAMS AND IN THE FUTURE TO AMEND THE HOUSING COMMISSION BUDGET TO INCLUDE THE FUNDS RECEIVED; AND 4) REQUESTING THE CHIEF EXECUTIVE OFFICER TO INFORM THE HOUSING AUTHORITY ON AT LEAST A SEMI-ANNUAL BASIS OF ANY AND ALL GRANTS APPLIED FOR AND/OR RECEIVED BY THE HOUSING COMMISSION

WHEREAS, the U.S. Department of Housing and Urban Development (HUD) published a SuperNOFA for Federal Fiscal Year (FFY) 2007; and

WHEREAS, the San Diego Housing Commission recommends Housing Authority ratification of Housing Commission applications for \$1,224,000 in funding for the following programs: Housing Choice Voucher FSS Program Coordinators; Public Housing FSS Coordinators; Resident Opportunities and Self Sufficiency Family and Homeownership; Resident Opportunities and Self-Sufficiency for Elderly and Persons with Disabilities, as further discussed in Housing Commission Report No. HCR07-55; NOW, THEREFORE,

BE IT RESOLVED, that Housing Authority does hereby ratify the Housing Commission's actions to apply for \$1,224,000 in funding pursuant to the SuperNOFA for Federal Fiscal Year (FFY) 2007.

BE IT FURTHER RESOLVED, that the Chief Executive Officer of the San Diego Housing Commission is authorized to execute contracts with HUD to accept the funds and to amend the FY08 Housing Commission Budget to receive the funds.

BE IT FURTHER RESOLVED, that the Housing Authority does hereby grant the Housing Commission Board authorization to approve future submissions of grant applications for resident initiatives programs and the ability to amend future Housing Commission budgets to include the funds, should these applications be approved, as discussed in Housing Commission Report No. HCR07-55.

BE IT FURTHER RESOLVED, that the Housing Authority does hereby request that the Chief Executive Officer inform the Housing Authority, on at least a semi-annual basis, of any and all grants applied for by the Housing Commission, and any and all grants received by the Housing Commission.
