A RESOLUTION APPROVING THE PROPOSED FISCAL YEAR 2013 SAN DIEGO HOUSING COMMISSION ANNUAL BUDGET IN THE AMOUNT OF \$349.1 MILLION AND DELEGATING TO THE HOUSING COMMISSION LIMITED AUTHORITY TO AMEND THE SAME.

WHEREAS, by Ordinance No. 0-12515 (New Series) the City Council has appointed the San Diego Housing Commission (Housing Commission) to handle certain administrative functions; and

WHEREAS, the Housing Commission's Board of Commissioners recommended that the Housing Authority of the City of San Diego approve the Proposed Fiscal Year 2013 Budget on April 13, 2012; and

WHEREAS, certain budget adjustments involving the transfer among programs of funds of not to exceed \$500,000 will be necessary during the course of the fiscal year which do not impact the total agency budget; and

WHEREAS, certain funding resources are estimated sources of revenue and the actual amount of funds received may vary from time to time; NOW, THEREFORE,

BE IT RESOLVED, by the Housing Authority of the City of San Diego that the San Diego Housing Commission Budget for Fiscal Year 2013, a copy of which is on file in the office of the Deputy Secretary as Document No. \_\_\_\_\_\_\_\_, is approved.

BE IT FURTHER RESOLVED, that the Housing Commission is authorized to approve line item transfers not to exceed \$500,000 of budget authority that do not impact the overall size of the Housing Commission's annual budget.

BE IT FURTHER RESOLVED, that the Housing Commission is authorized to

approve additional funding for the Fiscal Year 2013 Budget resulting from applications

submitted with the approval of the Housing Authority of the City of San Diego.

BE IT FURTHER RESOLVED, that in addition to funding from applications approved

by the Housing Authority of the City of San Diego, the Housing Commission is authorized to

approve additions, from other sources, not to exceed \$500,000 on an individual basis to the

Fiscal Year 2013 Budget.

BE IT FURTHER RESOLVED, that the President and Chief Executive Officer of the

Housing Commission is delegated that authority to amend the Fiscal Year 2013 Budget for

amounts not to exceed \$100,000 consistent with policies, programs and activities approved by

the Housing Commission and Housing Authority of the City of San Diego.

BE IT FURTHER RESOLVED, that the approval of the Fiscal Year 2013 Housing

Commission Budget is not a project and therefore is not subject to the California Environmental

Quality Act (CEQA), pursuant to State CEQA Guidelines Section 15378. This activity also is

exempt from the National Environmental Policy Act pursuant to 24 CFR 58.34(a)(3).
