A RESOLUTION OF THE HOUSING AUTHORITY OF THE CITY OF SAN DIEGO APPROVING AMENDMENT OF THE SAN DIEGO HOUSING COMMISSION'S STATEMENT OF PROCUREMENT POLICY.

WHEREAS, in 1994, the San Diego Housing Commission (Housing Commission) and the Housing Authority of the City of San Diego (Housing Authority) approved and adopted a Statement of Procurement Policy (PO203.100) (the Procurement Policy) for the Housing Commission; and

WHEREAS, the Procurement Policy now requires substantial amendment and revision and as such requires the approval of the Housing Authority; and

WHEREAS, the current Procurement Policy provides a solid basis for applicable federal procurement rules and regulations, but it does not, in detail, address state or local laws applicable to the Housing Commission; and

WHEREAS, since the Procurement Policy was last revised, the function of the Housing Commission's procurement department has developed and expanded; and

WHEREAS, Housing Commission desires to adopt a Procurement Policy that serves as a comprehensive manual covering all potential procurement conducted by the Housing Commission, utilizing both federal and non-federal funds and allowing the Housing Commission to exercise powers granted to it under state and local law; and
