A RESOLUTION AUTHORIZING THE SAN DIEGO HOUSING COMMISSION TO PAY DOWN UP TO \$1.5 MILLION IN PRINCIPAL ON THE SMART CORNER OFFICE BUILDING MORTGAGE LOAN EACH YEAR, PROVIDED THAT ADEQUATE FUNDS EXIST IN THE HOUSING COMMISSION'S HOUSING AUTHORITY-APPROVED BUDGET RESERVE, AND RELATED ACTIONS.

WHEREAS, on July 20, 2011, the San Diego Housing Commission (Housing Commission) Board approved the refinance of the Housing Commission's Smart Corner office building (Smart Corner); and

WHEREAS, on August 2, 2011, the Housing Authority of the City of San Diego approved the refinance of the Housing Commission's Smart Corner office building; NOW, THEREFORE,

BE IT RESOLVED by the Housing Authority of the City of San Diego, that the President and Chief Executive Officer of the Housing Commission, or designee, is authorized to take the following actions:

1. Pay down up to \$1.5 million in principal on the Smart Corner mortgage loan each year, provided that adequate funds exist in the Housing Commission's Housing Authority-approved budget and/or applicable reserves, and

2. Execute such documents and take such actions as are necessary, convenient and/or appropriate to implement this approval, upon the advice of General Counsel.
