SUBJECT: Fiscal Year 2016 Travel and Training Report

SUMMARY

The San Diego Housing Commission's (Housing Commission) travel and training expenditures during Fiscal Year (FY) 2016 (July 1, 2015 – June 30, 2016) totaled \$282,400, which is approximately 26 percent under the budget of \$381,880.

Attachment 1 shows the detail of out-of-town travel and training expenses for FY 2016. Attachment 2 displays a five-year comparison of actual expenditures compared to budget.

DISCUSSION

The comparison of the Housing Commission's travel and training expenditures to budget for FY 2012 through FY 2016 is provided in Attachment 2.

The actual-to-budget comparison report is followed by a detailed out-of-town travel and training expense report for FY 2016. Aggregated in-town travel and training expenses and total travel and training expenses for FY 2016 are presented on page 3 of Attachment 1.

During FY 2016, expenditures for out-of-town travel and training were \$195,406, and in-town training expenditures were \$86,994, totaling \$282,400. This total is an increase of \$19,737, or 7.5 percent, compared to the prior Fiscal Year's travel and training expenditures of \$262,663.
