Shelter Housing Initiative Update November 1, 2024 – January 15, 2025

- 153 households exited to permanent housing
 - 143 single adults
 - 10 families with children
- Of the 153 households:
 - Shelter Housing Initiative assisted 55 households.
 - 36 households diversion program
 - 19 households system coordination support from SDHC

Pause on Federal Grant Funding

- January 28, 2025: Federal Office of Management and Budget memo paused federal grants and loans for a variety of programs nationwide.
 - o The memo has been rescinded, but uncertainty remains.
- SDHC's focus: Making sure payments are made for rental assistance families that rely on SDHC.
 - SDHC spends approximately \$28 million per month on rental assistance programs.
 - SDHC was advised the freeze on federal funding did not apply to programs providing direct benefits, including rental assistance, or payments required by law.
 - SDHC needs to ensure it has the financial resources to make rental assistance payments for at least four to six weeks when unexpected disruptions occur.
- Aggressive federal actions demonstrate the critical importance of ensuring SDHC can continue to provide rental assistance payments for families with low income.
- National affordable housing groups responded, advocated and informed member organizations, including SDHC.
- Advocacy efforts continue, including letter to San Diego's congressional delegation.
