DATE OF FINAL PASSAGE **OCT 14 2020**

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE CHIEF FINANCIAL OFFICER TO EXPEND UP TO \$3,484,209.33 FROM THE GENERAL FUND TO SUPPORT AND EXPAND BRIDGE SHELTER ACTIVITY AND AUTHORIZING THE CHIEF FINANCIAL OFFICER TO SUBSTITUTE FUNDING SOURCES, IF AVAILABLE AND BENEFICIAL TO THE CITY, SUBJECT TO APPLICABLE ENVIRONMENTAL REVIEW.

WHEREAS, the San Diego Housing Commission (Housing Commission) administers the agreements for the City of San Diego (City)'s Homeless Shelters and Services Programs based on a Memorandum of Understanding between the Housing Commission and the City that first took effect on July 1, 2010; and

WHEREAS, in November 2017, the City and Housing Commission executed a separate Memorandum of Understanding for the Provision of Temporary Bridge Shelters, which was approved by the San Diego City Council and the Housing Authority of the City of San Diego, and which expired on June 30, 2020; and

WHEREAS, in July 2020, the City and Housing Commission entered into a new Memorandum of Understanding for the Provision of Temporary Bridge Shelters to identify the roles and responsibilities of the parties related to oversight and administration of the City's several temporary bridge shelters for a one year term, with two one-year options to renew; and

WHEREAS, due to changes in the homelessness crisis response system related to the COVID-19 pandemic, the City desires to expand the current bridge shelter at the San Diego Concourse and sections of Golden Hall by 280 beds to serve additional single adults. The existing 288 beds will be maintained to serve families and transitional-aged youth, subject to reductions due to social distancing implications; and

WHEREAS, the proposed bridge shelter expansion will require additional expenditures of previously budgeted funds; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego (Council), that the Council authorizes the Chief Financial Officer to expend \$3,035,354.15 from the General Fund, Homelessness Strategies Department budget, to support expanded bridge shelter activity at the San Diego Concourse and Golden Hall, and to expend an additional \$448,855.18 to support a further minor expansion of shelter opportunities if it is determined there is adequate physical and operational capacity, for a total not to exceed \$3,484,209.33.

BE IT FURTHER RESOLVED, that the Council authorizes the Chief Financial Officer to substitute other sources of funding (including Coronavirus Relief Funds, Emergency Solutions Grant funds, Homeless Emergency Aid Program, and Homeless, Housing, Assistance, and Prevention funds), if beneficial to the City and if substitute funding is available after accounting for other approved uses, only if and to the extent that the applicable environmental review is completed and clearance is received.
