SUMMARY

This report has been prepared in response to the Housing Authority of the City of San Diego (Housing Authority) Resolution Number HA-1569, which provides the San Diego Housing Commission (Housing Commission) authority for a number of grant-related activities and requires semi-annual reporting of all grant activity. It includes information about Housing Commission activity related to competitive grants, non-competitive grants and allocations, and pass-through funds from the City of San Diego (City) during the first half of Fiscal Year (FY) 2023 (July 1, 2022 – December 31, 2022). Grant funding approved for the Housing Commission to administer in response to the coronavirus (COVID-19) pandemic also is included in Attachment 1 of this report.

Grant Activity – Competitive Grants

During the first half of FY 2023, activity related to 16 competitive grant funding opportunities occurred.

Decision notices were received for six grant applications, including five awards totaling \$13,224,282 and one that was not awarded totaling \$12,500. Nine grant applications for a total of \$14,378,547.29 were pending decision as of December 31, 2022.

The Housing Commission, with support from the Regional Task Force on Homelessness, also submitted a "registration of interest" to the U.S. Department of Housing and Urban Development (HUD) for the maximum number of new Stability Vouchers available to the San Diego region via a formula allocation. These vouchers would provide rental assistance to individuals and families experiencing or at risk of experiencing homelessness. The registration of interest is the first step in a two-step selection process that is tied to the FY 2022 Continuum of Care (CoC) Supplemental to

Address Rural and Unsheltered Homelessness Notice of Funding Opportunity (Supplemental NOFA). As of December 31, 2022, the Housing Commission was awaiting the HUD announcement regarding awards for the Supplemental NOFA and the subsequent formal invitation to apply for the Stability Vouchers, which is the second step in the selection process.

Grant Activity – Non-Competitive Funding (Non-COVID-19 Related)

As the City's public housing agency, the Housing Commission is allocated non-competitive funds from HUD based on formulas and, on occasion, other factors. There was one non-competitive grant allocation totaling \$1,327,936 to the Housing Commission during the first half of FY 2023.

- **Contracts Awarded** During the first half of FY 2023, the Housing Commission executed two contracts totaling \$326,184.99 in HUD Capital Fund program funding that is allocated non-competitively to the Housing Commission. The annual HUD Capital Fund allocation is based on a formula that measures the existing modernization and accrual needs of public housing authorities. The funds are intended to be used for public housing units.
