#### SUMMARY

This report has been prepared in response to the Housing Authority of the City of San Diego (Housing Authority) Resolution Number HA-1569, which provides the San Diego Housing Commission (Housing Commission) authority for a number of grant-related activities and requires semi-annual reporting of all grant activity. It includes information about Housing Commission activity related to competitive grants, non-competitive grants and allocations, and pass-through funds from the City of San Diego (City) during the second half of Fiscal Year (FY) 2024 (January 1, 2024 – June 30, 2024).

#### **Grant Activity – Competitive Grants**

During the second half of FY 2024, activity related to 16 competitive grant opportunities occurred. This included nine new and five renewal applications.

Decision notices were received for 14 grants—12 grant awards totaling \$47,618,694 and two grant requests not awarded for a total of \$10,366,639. Attachment 1 provides additional information regarding the grant requests not awarded. One grant application requesting \$113,700 was pending decision, and a grant application to the State of California's Homekey Round 3 funding was withdrawn. The Homekey application, a proposed Willow Canyon project, was withdrawn after the State already had awarded more Homekey funds to San Diego than originally had been allocated for the San Diego region. With the award of Homekey funds for Presidio Palms, as noted in Table 1 below, and awards of Homekey funds for Pacific Village and Abbott Street Apartments, as discussed in the semi-annual grant report for the first half of FY 2024, the state awarded \$55.75 million in Homekey Round 3 funds to the Housing Commission for projects in collaboration with the City and the County, which was \$14.65 million more than the state originally had allocated for the entire San Diego region through this round of the Homekey program.

### Special Requests

Additionally, a \$1,500,000 competitive grant award to the City of San Diego from the FY 2024 Economic Development Initiative – CPF program will be used for capital improvements to convert publicly owned, unused office space at the Housing Commission’s headquarters into a shelter for transition-age youth experiencing homelessness. This funding request was made in collaboration with U.S. Senator Alex Padilla and U.S. Representative Scott Peters (District 50).

### Grant Activity – Pass-through Funding

As part of its approval of the City’s FY 2025 Budget, on June 11, 2024, the San Diego City Council (City Council) approved funding from five grant awards to be passed through to the Housing Commission to administer as the City’s public housing agency.

### Grant Activity – Non-Competitive Funding

As the City’s public housing agency, the Housing Commission is allocated non-competitive funds from HUD based on formulas and, on occasion, other factors. There was one non-competitive grant allocation to the Housing Commission during the second half of FY 2024 for a total of \$509,142.

- **Contracts Awarded** – During the second half of FY 2024, the Housing Commission executed five contracts totaling \$48,481.64 in HUD Capital Fund program funding that is allocated non-competitively to the Housing Commission. The annual HUD Capital Fund allocation is based on a formula that measures the existing modernization and accrual needs of public housing authorities. The funds are intended to be used for public housing units.

## **Attachment 1**

### **Grants Not Awarded – Additional Information**

**RTFH Super NOFO** – The Housing Commission submitted two requests under this NOFO for Diversion and Flex Shelter programs. Staff received feedback that the requests have been placed in a “deferred status.” Deferred status is not a commitment of future funding; however, it allows the RTFH to reconsider these programs at a later date should additional funding become available.

**EDD Opportunity Young Adult Career Pathway Program** – Feedback was requested and provided from the Grants and Solicitation Unit; The threshold was set at a score of 70 and higher to be considered for funding. SDHC’s application received 75 points out of 100. The program received 37 requests for funding and only 10 awards were made to the highest scoring applicants. Staff was advised that providing additional details regarding potential leveraged funds, indirect costs and program expenses in the Budget Summary and Narrative Plan will positively impact scoring in future applications.
