## NO ACTION IS REQUIRED ON THE PART OF THE HOUSING AUTHORITY

### SUMMARY

The San Diego Housing Commission’s (SDHC) grants team works collaboratively with departments to identify, evaluate, and apply for grant opportunities. This report has been prepared in response to the Housing Authority of the City of San Diego (Housing Authority) Resolution Number HA-1569, which provides SDHC authority for a number of grant-related activities and requires semiannual reporting of all grant activity. It includes information about SDHC activity related to competitive grants, non-competitive grants and allocations, and grant funds passed through to SDHC during the first half of Fiscal Year (FY) 2026 (July 1, 2025 – December 31, 2025).

### **Grant Activity – Competitive Grants**

During the first half of FY 2026, there was activity related to 13 competitive grant opportunities. This included nine new and four renewal applications.

SDHC received grant award notices for seven competitive grant applications, totaling approximately \$40,025,486<sup>1</sup>. One grant application requesting \$493,339 did not advance to the next step in the application process. As of December 31, 2025, five applications totaling \$6,537,853<sup>2</sup> were pending decision.

**Special Pending Grant Activity – HUD Continuum of Care Program**

On November 13, 2025, HUD published the FY 2025 Continuum of Care (CoC) Competition and Youth Homeless Demonstration Program Grants Notice of Funding Opportunity (NOFO) (FR-6900-N-25), which overrode provisions of its previous, two-year FY 2024-2025 NOFO and significantly altered eligible project priorities and criteria for that funding round.

On December 19, 2025, SDHC submitted seven new and three renewal project applications in response to the new FY 2025 NOFO, requesting a combined total of \$19,870,282. That same day, a federal judge granted preliminary injunctions regarding the FY 2025 NOFO in response to a lawsuit filed by several states, local governments, and nonprofit partners. That action temporarily restored the FY 2024-2025 NOFO and blocked HUD from implementing the FY 2025 NOFO published in November.

The court action also required HUD to process eligible renewal projects that were awarded funding under the FY 2024-2025 NOFO. SDHC had six such eligible renewal projects with a combined total of more than \$11.7 million. The 10 project applications that SDHC submitted under the FY 2025 NOFO were effectively paused pending further legal action. Additionally, HUD had until December 30, 2025, to communicate with communities and funding recipients about action steps they needed to take to process funding for eligible renewal projects.

No further direction from HUD about the CoC renewal funding processing had been published as of the end of this semiannual grant report period of December 31, 2025.

**Grant Activity – Pass-through Funding**

SDHC received pass-through funding from two grant sources in the first half of FY 2026 totaling \$18,541,893.

**Grant Activity – Non-Competitive Funding**

As the City’s public housing agency, SDHC is allocated noncompetitive funds from HUD or other sources based on formulas and, on occasion, other factors. No noncompetitive grant funds were awarded to SDHC during this reporting period.

**Economic Impact**

- **Sub-recipient Agreements** – During the first half of FY 2026, SDHC executed 23 sub-recipient agreements totaling \$28,776,712 that used grant sources in whole or in part.

The annual HUD Capital Fund allocation is based on a formula that measures the existing modernization and accrual needs of public housing authorities. The funds are intended to be used for public housing units.
