## **RESOLUTION NO. HC-2009**

## ADOPTED ON March 15, 2024

A RESOLUTION APPROVING THE SAN DIEGO HOUSING COMMISSION'S FISCAL YEAR 2025 SECTION 8 HOUSING CHOICE VOUCHER ADMINISTRATIVE PLAN AND RELATED ACTIONS.

WHEREAS, the U.S. Department of Housing and Urban Development (HUD) requires all public housing authorities, including the San Diego Housing Commission (Housing Commission), to adopt a written administrative plan that establishes local policies for the Section 8 Housing Choice Voucher program administration. The plan must state the public housing authority's policies in those areas where the public housing authority has discretion to establish local policy; and

WHEREAS, San Diego Municipal Code Section 98.0301(d)(3) authorizes the Housing Commission Board of Commissioners (Board) to adopt guidelines for the administration of programs previously approved and funded by the Housing Authority of the City of San Diego; and

WHEREAS, the Housing Commission's Fiscal Year 2025 Section 8 Housing Choice Voucher Administrative Plan incorporates updates HUD requires pursuant to the Housing Opportunity Realized through Modernization Act (HOTMA) of 2016, as described more particularly in Housing Commission Report No. HCR24-022; and

WHEREAS, on March 15, 2024, the Housing Commission Board approved the proposed Fiscal Year 2025 Section 8 Housing Choice Voucher Administrative Plan and related actions; NOW, THEREFORE,

BE IT RESOLVED by the Housing Commission Board as follows:

- The Housing Commission's Fiscal Year Section 8 Housing Choice Voucher Administrative Plan is approved.
- 2. The Housing Commission's President and Chief Executive Officer (President and CEO), or designee, is authorized to execute all documents and instruments necessary and/or appropriate to implement these approvals, in a form approved by General Counsel, and to take such actions as are necessary and/or appropriate to implement these approvals, provided that a copy of the documents, signed as to form by General Counsel, is submitted to each Housing Commissioner.
