Asking pet owners to choose between giving up their pets or choosing not to adopt a homeless animal, just to be able to live in public housing is unfair and clearly discriminates against lower income renters.*

This is unfair because this ruling would penalize people for simply being low income. Renters living in public housing should have the same rights and opportunities that everyone else residing in San Diego enjoys. You are also overriding a landlord's right to follow the current San Diego City pet ownership policies. San Diego currently limits dog ownership to six dogs (not including fish!). This should continue be an across the board citywide mandate. If someone living in public housing is able to provide a loving home for their animal that should be their decision and not the decision of some city government official, that has decided to override the current laws of animal ownership in San Diego.

This proposed policy is wrong: Are you aware that Southern California is facing a horrid problem of cat and dog overpopulation? Unfortunately the standard solution to this over-population problem, is to simply kill the adoptable animals in the shelter. By forcing people to make the decision between housing and keeping their companion animals, or adopting another. This policy could create a situation that would make a FORCED decision to relinquish their pets to shelter and possibly face euthansia .

Your cruel policy will harm animals and their owners. We know this may not be the intention, but it will certainly be an unintended consequence of such a cruel policy.

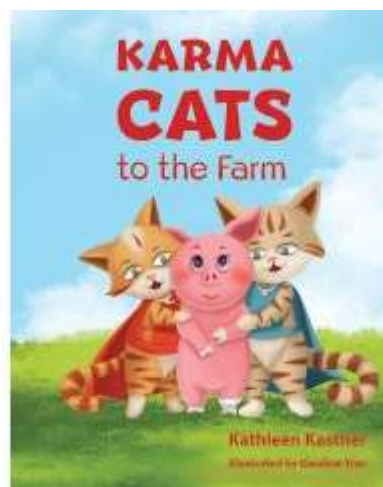
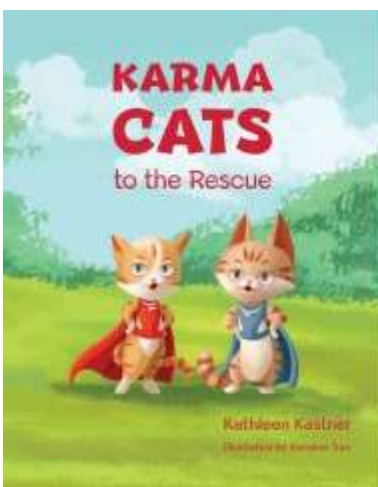
