Shelter Bill of Rights

*City and County of San Diego responsibilities to the welfare of sheltered individuals
by Lived Experience Advisers*

Whereas, every person residing at a shelter in San Diego County has the right to safety; to be treated with respect, compassion, and dignity; have adequate space and safe distances between beds in clean facilities; have access to adequate bathrooms and shower facilities; be provided with nutritious food that meets dietary needs and requirements; and be provided with professional case management to help as they move from the shelter to permanent housing, and,

Whereas, trained, compassionate, trauma-informed staff and case managers are essential to create a safe and welcoming atmosphere, and to assist people in finding housing services and financial assistance, including mediation with outside representatives before separation and independent reviews of any DNR status, and who are judicious and consistent when providing these services, including suspending a client, and,

Whereas every person residing in a shelter should have access to their personal property and secure storage to protect their valuables, including medications, personal documents, records, identification cards, and other items essential for their safety and well-being, therefore,

Be it Resolved that the undersigned agrees to support these services, ensure these conditions are available in all shelters throughout San Diego County, and to take actions to maintain and create these conditions as necessary.
