3. <u>Budget Revision – First Time Homebuyer Program</u>

Amend the Fiscal Year 2008 Housing Commission budget to reflect an additional \$1,200,000 from Centre City Development Corporation (CCDC).

Housing Authority approves the following action:

Approval of an amendment to the Fiscal Year 2008 Housing Commission budget to increase the Homeownership Loans and Grants by \$1,132,500 from \$5,439,130 to \$6,571,630 and to place \$67,500 in reserves for administration of the CCDC Downtown First Time Homebuyer Program.

4. Final Bond Authorization for Parkside Terrace Apartments (Council District 2)

Take the final step to authorize the issuance of Housing Authority mortgage revenue bonds for the development of Parkside Terrace Apartments.

Housing Authority approves the following action:

Authorize the issuance of up to \$17,114,159 million in housing revenue bonds to fund the development of the Parkside Terrace Apartments, a 77-unit apartment complex located at 505 13th Street in downtown San Diego.
