Housing Our Heroes Initiative Receives National Award

Housing Our Heroes, a partnership initiative between SDHC and the City of San Diego that helped secure housing for more than 1,000 Veterans experiencing homelessness, received an Award of Excellence from the National Association of Housing and Redevelopment Officials (NAHRO).

Housing Our Heroes was one of only 22 programs nationwide to receive the prestigious award, presented to SDHC Chairman of the Board Frank Urtasun, Vice Chair Stefanie Benvenuto and Commissioners Margaret Davis, Johanna Puno Hester and Kellee Hubbard at the NAHRO annual conference on October 26.

More than 430 individual landlords—nearly half of whom were new to working with SDHC—participated in Housing Our Heroes. The initiative was part of SDHC's homelessness action plan, HOUSING FIRST – SAN DIEGO.


