SUMMARY

The San Diego Housing Commission's (Housing Commission) travel and training expenditures during Fiscal Year (FY) 2023 (July 1, 2022 – June 30, 2023) totaled \$161,319, which is approximately 48.2 percent under the budget of \$311,370. While the travel restrictions the Housing Commission implemented on March 10, 2020, as a precaution to maintain employee safety and to help prevent the spread of COVID-19 were lifted during FY 2023, travel and training expenditure remained significantly under budget. Attachment 1 shows the out-of-town travel and training expenses for FY 2023. Attachment 2 displays a five-year comparison of actual expenditures compared to budget.

HOUSING COMMISSION STRATEGIC PLAN

This item relates to Strategic Priority Area No. 3 in the Housing Commission's Strategic Plan for Fiscal Year (FY) 2022-2024: Investing in Our Team and the Core Value of believing in transparency and being good financial stewards.

DISCUSSION

The comparison of the Housing Commission's travel and training expenditures to budget for FY 2019 through FY 2023 is provided in Attachment 2.

The actual-to-budget comparison report is followed by a detailed out-of-town travel and training expense report for FY 2023. Aggregated in-town travel and training expenses and total travel and training expenses for FY 2023 are presented in Attachment 1.

During FY 2023, expenditures for out-of-town travel and training and in-town training expenditures were \$161,319. This total is an increase of \$67,555 (72 percent) compared to the prior Fiscal Year's travel and training expenditures of \$93,765.
